Dear Senator:

As representatives of nonpartisan organizations committed to improving health care for all children, we are writing to urge your support for H.R. 2, the Children's Health Insurance Program Reauthorization Act, to renew the Children's Health Insurance Program (CHIP) currently being debated before the Senate.

Since 1997, CHIP has been a vital program for low-income children in working families whose parents earn too much to qualify for Medicaid but too little to purchase private health insurance, which now costs on average \$12,000 per year for families. By all measures, CHIP has been a success story. The children's health program has reduced the number of uninsured children in America by over one-quarter and has improved both health outcomes and access to care for millions of children across this nation. The American public recognizes that success and, in poll after poll, has expressed overwhelming support for CHIP.

Nevertheless, there are still an estimated nine million uninsured children in our nation and a shocking 6 million of those uninsured kids are already eligible but not enrolled in either Medicaid or CHIP. And, with the economic downturn, more and more families now find themselves without employer-sponsored insurance and in need of affordable coverage options for their children.

The legislation before the Senate is estimated to provide health insurance coverage to 4.1 million uninsured children across our country and over 80 percent of them are estimated to be children who are currently eligible but not enrolled. It achieves this bipartisan goal by providing states with the funds they need to sustain and strengthen their CHIP programs, including the growing number of children who need coverage in light of the recent economic downturn; financial incentives to states to enroll the eligible but not enrolled; funding for outreach and enrollment; and the ability to simplify both Medicaid and CHIP enrollment procedures and ease paperwork requirements so that children can enroll in and receive health coverage through measures such as Express Lane Enrollment.

The legislation also takes the important step of eliminating the five-year waiting period to access health care services through Medicaid and CHIP for legal immigrant children and pregnant women. The immigrant children and mothers who would no longer be required to wait five years for health care are all lawfully residing in the United States with permission to remain in the country permanently and are on a path to citizenship.

These children and mothers should not be forced to wait five years for health care, as five years is a lifetime for a child. Timely coverage can mean the difference between preventing or treating conditions that can affect a child's long-term prospects for a healthy productive life or leaving those conditions undetected and untreated.

For example, any child with asthma, autism, hearing or vision impairments, and birth defects – conditions with life-long consequences for children's health and well-being – cannot wait five

years for treatment. Any child in need of preventative or public health services, such as immunizations or treatment for infectious diseases, requires those services to be delivered in a timely manner. Also, denying or delaying children with cancer or disabilities the treatment or rehabilitative services they need is simply not what our country stands for.

As for expectant mothers, it is, by definition, nonsensical to ask them to wait five years to get the prenatal care needed to ensure the birth of a healthy newborn child.

Consequently, as organizations dedicated to ensuring that all children should have access to coverage, we urge the Senate to oppose and defeat any amendments or provisions that would:

- Impose any new coverage limitations, restrictions, or caps on coverage of children that could possibly increase the number of uninsured children or limit the ability of states to extend coverage to uninsured children in their state just as more families than ever need affordable coverage options;
- Impose any additional bureaucratic and paperwork burdens upon children that would limit access or impose barriers for them to receive the health care services they need (for example, the General Accounting Office (GAO) found that six states implementing citizen verification requirements spent \$8.3 million to find only eight ineligible immigrants in a caseload of 3.65 million people, funds that could have been used much more effectively to provide coverage for uninsured children. According to the GAO, these states have recouped a mere \$11,048 in total, less than 1 percent of the additional bureaucratic and paperwork costs, while tens of thousands of eligible U.S. citizens have lost coverage due to these new requirements); and
- Undermine efforts to simplify enrollment and outreach efforts, particularly to the millions of low-income children currently eligible for but unenrolled in Medicaid and CHIP.

We know you agree that our children are our nation's most precious resource and that investments in health care for kids reap benefits that last a lifetime. We thank you for making children's health an early priority in this Congress and urge you to stand with our children and to put their needs first and foremost in the consideration of any amendments during the forthcoming debate.
